# E.M. Fletcher Writing Award 2020

## **Terms and Conditions**

The HAGSOC Writing Competition is an initiative of the Heraldry and Genealogy Society of Canberra (HAGSOC). Entrants will compete for the E.M. Fletcher Writing Award, named in honour of Society Fellow Eunice Fletcher (a long-time member who had significant input into the formation of the Society over many years).

Applicants will need to complete **a separate entry form** with their contact details and submit this with their entry.

#### TERMS AND CONDITIONS OF ENTRY

- 1. The E.M. Fletcher Writing Award 2020 is administered by the HAGSOC Writing Competition Committee.
- 2. By entering this Competition, you agree to be bound by its Terms and Conditions.

#### **COMPETITION DATES**

- 3. The 2020 Competition opens at 9.00 am 15th February 2020 (AEST).
- 4. The 2020 Competition closes at 11.59 pm 15th July 2020 (AEST).
- 5. Award winning entries will be notified by 1st October 2020.
- 6. No entries will be accepted after the Competition closes on 15<sup>th</sup> July 2020.

#### WHO CAN ENTER

- 7. The Competition is open to individuals over 18 years of age. Anyone aged 14 years to 17 years may enter if they have parental consent (an email from the parent or guardian will be accepted).
- 8. The Competition is open to residents of Australia.
- 9. Members of the HAGSOC Writing Competition Committee and Competition judges are ineligible to enter.

#### **COMPETITION THEME, WORD COUNT, PRIZES AND FEES**

- 10. The Competition will be judged to select, in the opinion of the judges, the best short story on a family history/genealogy theme. The genre of writing is not limited, so try your hand at non-fiction, biography, creative non-fiction or fiction. Whether you are telling a story about one of your ancestors or sharing a personal memoir, the broad theme allows plenty of scope to be creative.
- 11. Word count for the short story is to be between 1,500 and 2,000 words. The word count includes the title but the repeated title and page numbering on each page is not included.
- 12. References are not required. It is the author's decision whether to include references. References will not be included in the word count.
- 13. A maximum of two photographs or illustrations may be included, if they are specific to the story (i.e. not a generic illustration). Captions should be 10 words or less for each photograph or illustration and are not included in the word count.
- 14. Prizes being offered are: Best story: \$1,000; HAGSOC member prize: 12 months membership of HAGSOC and a \$75 Society voucher.
- 15. If the winner of the best story is a HAGSOC member that person will receive all prizes.
- 16. Other prizes may be awarded at the judges' discretion.

- 17. An entry fee of \$20 for HAGSOC members or \$30 for non HAGSOC members is payable for each entry at the time it is submitted.
- 18. There is no limit to the number of entries that can be submitted but each entry requires payment of a separate entry fee.

#### HOW TO ENTER AND ENTRY RULES

- 19. Entries can be submitted on line though the HAGSOC web-site http://www.familyhistoryact.org.au
- 20. Electronic entries must be submitted as PDF, MS Word or RTF.
- 21. Entries may also be posted to the Secretary, HAGSOC, PO Box 152, Jamison Centre. ACT 2614.
- 22. The entry fee must be paid at the time each entry is submitted.
- 23. Please do not include the author's name or any identifier within the story. Remember to include your name and contact details on the separate entry form.
- 24. All authors must provide their own name on the entry form for administrative purposes. If you would prefer your story to be published under a pseudonym please note it on the entry form.
- 25. Entrants will receive an acknowledgement of their submission.
- 26. Entrants must retain copies of their stories submitted and no changes can be made to any entry after it has been submitted. Entries will not be returned.
- 27. It is the entrant's responsibility to ensure that any postal entries are received by HAGSOC by the closing date, 15th July 2020.
- 28. Each entry must be the work of the entrant and must not infringe on anyone's copyright or be under contract at the time of entry. The story must not have been submitted to any other competitions or to any publishers and must not have been published previously.
- 29. The entry submitted must be in English, double-spaced, in 12-point font and each page must include the title and a page number.

#### JUDGING AND AWARDS

- 30. Entries will be judged anonymously by independent judges selected by the HAGSOC Writing Competition Committee.
- 31. The judges may determine that a prize will not be made if the entries are not considered to be of sufficient merit or if insufficient entries are received.
- 32. All decisions made by the judges are final and no correspondence will be entered into. Prizes are awarded at the judges' discretion.
- 33. The award winners will be notified in writing and winners announced on the HAGSOC web-site.

### COPYRIGHT, LIABILITY AND PRIVACY

- 34. Personal details on entry forms will not be shared by HAGSOC with any third parties.
- 35. Copyright in all entries submitted will remain with the author at all times. However all authors give HAGSOC a non-exclusive, personal and royalty-free licence to publish their entries for two years. There will be no payment (other than prize money) made to authors of published entries. On completion of the awarding of the prizes, the licence to publish shall be null and void in respect of every entrant other than the winner and the runners-up.
